Description

A single villa within the Milano Visconti estate, an area once used as the hunting reserve of the Sforza family.

The estate has extensive amenities including Michelin-starred restaurants, health club with pool, gym

and tennis courts, 24 h surveillance, bike tracks and children parks. The villa is set on 3 levels plus attic; it has a double entrance, 2 living rooms which overlook the private garden, a large kitchen, a master suite and 2 further bedrooms, 4 bathrooms. The attic contains a study and a recreation area. There is the possibility to build a pool in the ground. The property also has a double garage and large terraces which overlook the garden.

The villa is set close to the Visconti Castle which was built by Bernabò Visconti in the XIV century. It reached its splendor in the XV century thanks to Ludovico il Moro, Master of Milan and his wife Beatrice d'Este.

The surrounding area is known as the South Park of Milan, with many farms producing organic products.

There are several excellent golf courses and riding schools in the area too.
